

REGULAR MEETING LAURENS CITY COUNCIL --CITY HALL
MONDAY APRIL 7, 1958 7 P.M.

Present: Mayor Medlock, Aldermen Stoddard, Brownlee, Strange,
Davis, Cook, and Roberts.
Also Present: Mayor-elect Culbertson and Councilman-elect
Mitchell.

Meeting was called to order by Mayor Medlock and the minutes of
the previous meeting were read and approved.

Mayor Medlock read a resolution from the Board of Directors of
the Chamber of Commerce which recommended to the Mayor
and the City Council the adoption of the Metropolitan
Numbering System for the City of Laurens.

Motion by Alderman Cook that the City adopt the Metropolitan
Numbering system and that new signs marking the names
of streets be installed.
Seconded by Ald. Strange
Motion carried Unan.

Motion by Ald. Brownlee that the City donate \$200.00 to the
American Legion Baseball team.
Seconded by Ald. Roberts
Motion carried unan.

Motion by Ald. Brownlee that the City donate \$300.00 to the
Pony League baseball program.
Seconded by Ald. Davis
Motion carried unan.

Motion by Ald. Cook that the City General Election be held on
Tuesday June 3, 1958.
Seconded by Ald. Brownlee
Motion carried unan.

Motion by Ald. Brownlee that a policeman be hired for the months
of June, July and August 1958 at a salary of \$50.00 per
week. This action taken in order to allow the members of
the Police Department to take annual 2 week vacation.
Seconded by Ald. Davis.
Motion carried unan.

Motion by Ald. Davis that a committee of not less than five nor
more than seven citizens of Laurens be appointed by the
Mayor, who shall designate the chairman of such committee
for the purpose of making a study of the need and desir-
ability of establishing a zoning or planning commission
for the City of Laurens and that such committee make a
report of its findings along with any proposed ordinance
which it considers to be in conformity with its findings
for the consideration of the Mayor and Council upon the
conclusion of its study.
Seconded by Ald. Strange
Motion carried unan.

Motion by Ald. Davis that the City lease a lot on South Harper
Street from Mr. W.G. McDaniel. The lot to be used for
providing parking area. The terms of the lease will be
\$75.00 per month for ten year period with option to
renew. The Mayor and City Attorney are hereby authorized
to draw up the lease and execute same for the City. The
lease to take effect July 1, 1958.
Seconded by Ald. Cook.
Motion carried unan.

Motion by Ald. Davis that the City re-hire Marion Craine and
Henry Isaac to run the City recreation program. Program
to begin May 15 and run through August 31. Salary to be
\$25.00 per week until June 1 and \$40.00 per week for
June, July and August.
Seconded by Ald. Cook and Carried Unan.

Motion to adjourn by Ald. Stoddard, Seconded by Ald. Davis, Carried
and so ordered.
