 Time: 4.15 P.M.
 Place: City Hall

 Present: Mayor Culbertson, Aldermen Cook, Hedgepath, Davis,
 Strange and Mitchell.

The meeting was called to order by Mayor Culbertson.

That the Mayor and City Clerk be authorized to enter into contract to expend the sum of \$307.00 for the installation of "curb cops" on parking meters.

That the time limit on parking meters on the square be changed from two hours to one hour when the parking lot is completed.

Motion by Ald. Jack Davis that the motion presented by Ald. P.A. Mitchell and seconded by Ald. Davis and adopted in regular meeting on April 11, 1960 wherein the City of Laurens agreed to reimburse Mr. T. Suddeth for 80' of 24" pipe within the next fiscal year be stricken from the records and that in lieu thereof the City agrees that in consideration of the purchase of aprox. 153 feet of 24" pipe by T. Suddeth and Mamie K. Suddeth to replace the 15" drain pipe now being used to drain street water across their property the City will repay the said T. Suddeth and Mamie K. Suddeth by crediting their tax indebtedness to the City of Laurens until a sum equal to the cost of said pipe has been reimbursed by the City, it is understood that no interest will be paid on the money advanced.

Seconded by Ald. Cook
 Motion carried.

Motion by Ald. P.A. Mitchell that the City of Laurens purchase 79 double meters from Dual Meter Co. at a cost of \$94.50 and 5 single meters at \$58.00 for a total cost of \$7,755.50 to be repaid in monthly installments the sum equal to one-half the revenue from the meters on the parking lot consisting of the property rented from Mrs. Euphemia Bryson and the property formerly used as a city barn. The said meters to be timed in the following manner: 82 meters timed at 1 1/2 hours for 5¢ and 3 hrs. for 10¢. 84 meters timed at 2 hours for 5¢, 4 hours for 10¢ and 10 hours for 25¢. Provided the Dual Meter Co. will pay all expenses for factory training at Tulsa, Okla. for one week for a service man. Provided further, that five extra timing mechanisms, two cases, parts, tools, and coin collecting cart be furnished to the City by Dual Meter Co. at no additional cost and provided further that the Dual Meter Co. be responsible for paying the full cost of changing the timing of the meters on the square from ~~one hour~~ two hours to one hour

Seconded by J.O. Hedgepath and Carried Unan.
