MINUTES LAURENS CITY COUNCIL

APRIL 19, 1983

PRESENT: Mayor Dominick, Council members Cox, Crabtree, Franks, Garrett, Henderson, Stewart, and Administrator Willett.

The minutes of the meeting of the March 15, 1983, as amended, and of April 11, 1983, were approved.

Mayor Dominick called on Mr. Robbie Armstrong of the YMCA who brought the Council up-to-date on City recreation activities and proposed summer activities. Mr. King Dixon of the YMCA informed the Council of how all monies collected from the sale of consessions and tournaments were utilized. Mr. Dixon presented a proposed recreation budget of \$27,000.00. On a motion by Mr. Franks and seconded by Mrs. Cox, Council unanimously agreed to allow the Babe Ruth Baseball League to sell concessions on the lower field provided they maintain the facility and be responsible for all damages. The YMCA will be required to make at least weekly inspections of the facility to be sure it is being maintained in an appropriate manner. Council directed the Recreation Committee to investigate the tournament fees policy and to report back to Council as to what should be done with these fees.

Mayor Dominick called on Mr. David Smith, president of the Laurens County N.A.A.C.P. Mr. Smith questioned Council as to why it has taken three years to decide whether or not to go to single member districts. Mr. Smith also asked Council whether or not they intended to go to single member districts. Mayor Dominick answered by saying that the City has just recently reviewed maps dividing the City into six equal wards. Mayor Dominick also said that an Election Committee had been appointed, and that they would be asked to give Council a recommendation on his question. Council discussed the possibility of holding a public referendum to guage the public's opinion.

On a motion by Mr. Franks and seconded by Mr. Henderson, Council unanimously denied a request to reduce both the business license and building permit fees for South Atlantic Construction Company.

On a motion by Mr. Franks and seconded by Mr. Henderson, Council unanimously approved on second reading an ordinance amending the Minimum Standards by attaching the "Project Manual for Facade Repair".

On a motion by Mr. Franks and seconded by Mr. Henderson, Council unanimously approved on second reading an ordinance amending the budget to include \$28,000.00 for roof repair of the Police Station.

Council unanimously appointed the following persons to their respective boards: Joe Adams and Carroll Allen - Mechanical Board; James Williams, Sam Wallace, Otis Babb, Von Long, and D.A. McDaniel - Plumbing Board; James Goss, Lawrence Aiken, Robert Hill, Arvy Brewster, and James Rush - Electrical Board; Isaac White, Fred Davis, Sr., Edsel Culbertson, and Robert Jones - Planning and Zoning Commission.

There being no further business, the meeting was adjourned.
